Upon investigation, you find his spine is broken in half. The family is requesting a cremation.

Scenario 2

 Nadia, a foreign national, falls out of a boat on Lake Tawakoni. The ME, following an autopsy, rules the death a drowning, and also determines that she was pregnant at the time of death. The next of kin cannot be determined.

• Lucy is taken to the hospital ER unresponsive, where she dies. Some bruising was found and ligature marks around the neck. Police notify you that her husband, Barry, currently has an EPO against him, protecting Lucy, set to expire in two days. They have three children: Josh who is 19 and currently in college at the University of Oklahoma, Lisa (12) who found her mom and called 911, and a third child that is 7 months old named Max. Lucy's parents demand to see the body. Barry says he wants to Lucy cremated.

Scenario 4

• A plane carrying six people crashes in a field right on the county line. Three bodies are found in your county. Two are found in the other county, and parts of another body are found in both counties.

• The deceased is Joe, a United States citizen, 45 years old, 5' 3" and weighs 300 pounds. Joe's religious beliefs do not allow the cutting of the body. The ER doctor saw signs of a cardiac event and believes the death is natural, but will not sign the death certificate. He was complaining of chest pains and called 911 and was alive when he was brought to the ER.
